How do I open and manage my account?	<ul> <li>To open an Account you must be: <ul> <li>a Small to Medium Enterprise with fewer than 250 employees and either assets of less than £37.5 million and/or turnover of less than £43.5 million</li> <li>a UK based business operating as either a sole trader, partnership, Limited Liability Partnership (LLP) or Limited Company</li> <li>not be in our exclusion list, which is available on our website</li> </ul> </li> <li>The Account must be for business use only, not personal use.</li> <li>You can apply online through our website at www.recognisebank.co.uk. You need to provide some personal and business details to open your Account.</li> <li>There is a minimum deposit of £1,000. The maximum balance you can hold depends on what type of business you are.</li> <li>For Limited Companies and Limited Liability Partnerships (LLP) the maximum is £250,000 per business entity.</li> <li>For Sole Traders or Partnerships, the maximum is £85,000 across all your Recognise Savings Accounts, including your share of a Business Savings Account and any Personal Savings Accounts you may have.
